The applicant agrees to take service for a period of three years at the rate under the company's schedule in effect from time to time in accordance with the rules and regulations on file with the Public Service Commission of Wisconsin for the class of service applicable. The company shall be responsible to supply service based on the service load indicated above by the applicant. The applicant agrees to guarantee a minimum of \$_____per_____ during the first three years of service.

Applicants for new permanent service may be required to contribute to the company a sum equal to the excess of the cost for the extension of new electric service over the free limit as established by the Public Service Commission. The cost for extension (Contribution in Aid of Construction) shall be determined by the company for the cost of construction based on the usage and loads indicated above by the applicant. The applicant is not obligated to receive electric service from the company until having made payment of the contribution over the free limit allowed. The amount of contribution (provided any is required) must be paid in order for the applicant to receive electric service and must be paid for in advance of installation. This application for Electric Service shall not be binding upon Dahlberg Light & Power Company unless a sufficient number of customers can be secured to make the extension possible and until approved by its proper authorized representative.

This application shall be deemed to be renewed for successive annual periods, unless terminated by written notice (30) days prior to the expiration of any such period.

Continuity of Service

The utility will use reasonable care to provide an uninterrupted and regular supply of service to its customers. It does not assume direct liability for losses or damage to persons or property due to its service, or as a result of the service, interruption or variation because of an Act of God, strike or any causes beyond the utility's control.

The utility reserves the right to curtail or temporarily interrupt the customer's service when necessary to make repairs, replacement or changes to the utility's facilities either on or off the customer's premises.
